

**FACTS****WHAT DOES REICH & TANG DEPOSIT NETWORKS, LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Address
- Phone number and Bank balances

When you are *no longer* our customer, we continue to share your information as described in this notice.

**How?**

All financial companies need to share **customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers'** personal information; the reasons **Reich & Tang** chooses to share; and whether you can limit this sharing.

## What we do

How does Reich & Tang protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Reich & Tang collect my personal information?

We collect your personal information, for example, when you

- Participate in DDM or Participate in broker sweep program
- Apply for a debit card or Apply for checkwriting privileges

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

## Other important information

If you participate in a cash management program, Reich & Tang or its affiliates may share your confidential information in the course of everyday business with participating banks. If you have a debit card or checkwriting privileges, Reich & Tang may share certain of your confidential information with certain service providers.
